PROCEEDINGS

Members absent were none. Employees attending were Rhonda Morrison, Carl Trahan, and Aaron Jinks. The guests attending were Charles Bull and Troy Richard.

It was moved by Nathan Griffith to call the meeting to order.

The pledge was said by all present and the prayer was led by Connie Trahan.

It was moved by Mark Young to approve the agenda as presented. No comment was given. The motion was seconded by Kent Carlson and carried by all.

A Public Comment period was given on all agenda items. No comment was given.

It was moved by Connie Trahan, seconded by Bobbie Trahan, and carried to accept the January minutes as read.

Charles Bull and Troy Richard discussed the desire and need to obtain water on Egret Street. The Board of Directors are waiting for the survey that was ordered by the Cameron Parish Police Jury. Egret Street water will be discussed at the next meeting.

Cost of living raises were discussed. It was moved by Bobbie Trahan to give the 4 employees a 5% cost of living raise. Mark Young abstained from voting. No public comment was given. The motion was seconded by Kent Carlson and carried.

It was moved by Bobbie Trahan to give Aaron Jinks a \$2.00 an hour increase in pay in addition to the 5%. Mark Young abstained from voting. No public comment was given. The motion was seconded by Connie Trahan and carried.

It was moved by Mark to give Rhonda Morrison an additional .09 an hour in addition to the 5%. No public comment was given. The motion was seconded by Connie Trahan and carried.

Full-time secretary applications were reviewed. The board tabled the decision until the March meeting.

The fire hydrant inspection report was discussed. More discussion will take place at the March meeting.

It was moved by Connie Trahan, seconded by Bobbie Trahan, and carried to approve the bank statements and the Actual vs. Budget report for the month ending January 2025.

It was moved by Connie Trahan, seconded by Kent Carlson, and carried to approve the bills as paid.
