It was moved by Nathan Griffith to call the meeting to order.

The pledge and prayer were said by all present.

It was moved by Mark Young to accept the agenda as presented with changes. The motion was seconded by Kent Carlson and carried.

A Public Comment period was given on all agenda items. No comment was made.

It was moved by Kent Carlson, seconded by Mark Young, and carried to accept the September minutes as read.

Charles Bull discussed a water line extension on Egret Street. The project will be investigated further and details provided to Mr. Bull once received.

HR Director Trudi Dewey reviewed drug policies, whistleblower laws, and FMLA with the Board members and employees.

The Board discussed an increase in pay for Shannon Hebert in regard to her 6-month employment evaluation. It was moved by Kent Carlson to give Shannon a \$2.00 an hour raise. No comment was made. The motion was seconded by Mark Young and carried.
